In exercise of the power entrusted by the Concerned office Order (Memo No.30.069.025.06.00.003.2011-144(500) dated 19-06-2011 A.D. and 05-03-1418 B.E) issued from the Honourable Prime Minister's Office, Government of the People's Republic of Bangladesh, Rinku Majumder, Assistant Professor, Physics Discipline in Khulna University, Khulna, Bangladesh, has been granted study leave for a period of 02 (two) years with effect from November 10, 2021 to November 09, 2023 with full average pay and GO of total period 02 (two) years to pursue Ph.D program in MEXT Scholarship of the Graduate School of Natural Science and Technology of the Division of Mathematical and Physical Sciences in Kanazawa University, Japan. He will be temporarily released from his duties at the University from the afternoon of November 09, 2021. He has been permitted to leave Bangladesh and stay in Japan on the following terms and conditions:

- a) The Government of Bangladesh or the Khulna University authority will have no financial obligation in this connection with his study abroad.
- b) He will have to execute a Bond in the prescribed form with the University Authority.
- c) He will have to return to Bangladesh and resume his duties at the University immediately after the expiry of his study leave.
- d) His study supervisor will have to send his study progress report to the Registrar, Khulna University through concerned Head and Dean on his (supervisor) official letterhead pad under confidential cover in every six months.
