In exercise of the power entrusted by the concerned office order (Memo No.30.069.025.06.00.003.2011-144(500) dated 19-06-2011 A.D. and 05-03-1418 B.E) issued from the Honourable Prime Minister's Office, Government of the People's Republic of Bangladesh, Aisha Rahman Asha, Lecturer, English Discipline in Khulna University, Khulna, Bangladesh, has been granted study leave for a period of 02 (two) years with effect from January 09, 2023 to January 08, 2025 with on self pay and GO of total period of 02(two) years to pursue Ph.D. program of Department of English, Dalhousie University, Halifax, Nova Scotia, Canada. She will be temporarily released from her duties at the University from the afternoon of January 08, 2023. She has been permitted to leave Bangladesh and stay in Canada on the following terms and conditions:

- a) The Government of Bangladesh or the Khulna University authority will have no financial obligation in this connection with her study abroad.
- b) She will have to execute a Bond in the prescribed form with the University Authority.
- c) She will have to return to Bangladesh and resume her duties at the University immediately after the expiry of her study leave.
- d) Her study supervisor will have to send her study progress report to the Registrar, Khulna University through concerned Head and Dean on her (supervisor) official letterhead pad under confidential cover in every six months.

Provided that the office order Memo No. KU/Reg./ Estab-2-1095/18-458, Date- June 23, 2022 has been cancelled hereby. This Office Order has been issued with the approval of the authority.
