Office Order

Tarik Morshed, Assistant Professor, Law Discipline in Khulna University, Khulna, Bangladesh, has been granted study leave for a period of 09 (nine) months 13 (thirteen) days with effect from October 03, 2022 to July 15, 2023 with full pay and GO of total period of 09 (nine) months 28 (twenty eight) days with effect from September 18, 2022 to July 15, 2023 including recreation leave (18-09-2022 to 02-10-2022) to pursue MSc in Refugee and Forced Migration Studies with Prime Minister Fellowship in University of Oxford, United Kingdom. He will be temporarily released from his duties at the University from the afternoon of September 17, 2022. He has been permitted to leave Bangladesh and stay in United Kingdom on the following terms and conditions:

- The Khulna University authority will have no financial obligation in this connection with his study abroad.
- He will have to execute a Bond in the prescribed form with the University Authority.
- He will have to return to Bangladesh and resume his duties at the University immediately after the expiry of his study leave.
- His study supervisor will have to send his study progress report to the Registrar, Khulna University through concerned Head and Dean on his (supervisor) official letterhead pad under confidential cover in every six months.


